2. Capital Budget Presentation

2.1. District of North Vancouver

2020 Capital Projects Murdo Frazer Pond Restoration

- New accessible ramp and new deck.
- Ecological restoration in denuded areas and old closed pathways to bring natural environment back around pond.

Playgrounds - (Sunnyhurst Park)

Three new playgrounds were installed in Sunnyhurst, Delbrook & Dudley Place during the summer. All three playgrounds were well received by the community and were used immediately after installation.

Accessible features include:

- Accessible play items at each playground, including DNV Park's first ever horizontal roller slide (Delbrook Park)
- Accessible items that can be accessed from the ground and include stretching, making music,

Playgrounds - (Dudley Place Park)

Dudley Place is now featured on a MUST VISIT playground to experience – local Vancouver mums website...

Accessible features includes:

- Accessible play items at each playground, including DNV Park's first ever horizontal roller slide (Delbrook Park)
- Accessible items that can be accessed from the ground and include stretching, making music.

Lynn Canyon Park

New paving, drainage and circulation work at Lynn Canyon was completed in August 2020.

• Both upper and lower parking lots are now open (in new configuration)

New accessible features include:

- New handicapped parking spots close to Ecology centre and café.
- Pedestrian only broad multi-use walkway from Ecology centre to Café
- New automatic doors for the café and Ecology centre
- Pathways and curb cuts for ease of access
- Accessible picnic tables

New paving, drainage and circulation work at Lynn Canyon was completed in August 2020.

• Both upper and lower parking lots are now open (in new configuration)

New accessible features include:

- New accessible parking spots close to Ecology centre and café
- Pedestrian only broad multi-use walkway from Ecology centre to Café
- New automatic doors for the café and Ecology centre
- Pathways and curb cuts for ease of access
- Accessible picnic tables
- Wide pathways in and around the upper parking lot for ease of movement.

- Accessible parking spaces close to attractions
- Clearly marked pedestrian walking paths across road
- Need for high reflective colour for
- Ecology Centre new accessible doors front and back...removal of curbs to make it easier to move from one surface to the other
- New signage that is easier for the visually impaired to see.
- DNV Parks working on a new comprehensive signage system for Lynn Canyon Park for 2021

Ideas to allow more visitors to enjoy the falls experience:

- (Viewing platform somewhere by the café...looks at locations where one can see a bit of the falls
- By octagon sign by bridge stairway 3 d model of canyon and falls for visitors to touch and feel to experience the falls

(these ideas were presented during the ACDI Lynn Canyon Park walkabout last summer)

• **UPDATE**: Ecology Centre working on a 3D model of Lynn Canyon and falls for the public to experience. 2021

McCartney Creek Park Backstops

DNV Parks replaced all four existing backstops at McCartney Creek Park's East field.

Accessible features include:

- New accessible trail links from parking lot, fieldhouse to field
- Ease of transition from field to backstop area
- Improved signage

Seylynn Park

The first phase of Seylynn Park was completed in the fall of 2020 The renovated park will include:

- Multi use Field area to accommodate a variety of uses, including sports games-special events
- New entry plaza area at corner of Hunter and Mtn Highway
- New community gardens
- Special event areas stage
- Playground and small washroom
- Natural play areas and trails

Detailed design – 2018

Construction of Phase 1 (area south of Seylynn Rec Centre) 2019/2020 Pathways – different textures denotes

Pathways – main oval path around open grass area – side, textured and seamless Seating areas are incorporated into the planting areas and provide a safe boundary between public and natural areas

Special accessible seating with handrails around main oval

Mountain Highway Interchange

Ongoing construction of the Mountain Highway Interchange features new trail connections (red clouded area)

New trails will include:

- Seating and signage information board areas along the route
- Access to the Spirit Trail connections
- Areas to stop and appreciate the new planting beds and new exposed creek area
- Connections to existing parks trails along Lynn Creek
- Wide multi-use pathways to access Spirit trail and existing park trails network

Myrtle/Delbrook Backstop Upgrades

- Replacement mini-backstop for the 3-5 year old baseball league NE side of allweather field
- Field will be regraded before 2021 season

Myrtle/Delbrook Backstop Safety Netting

- New safety netting section for Myrtle NW backstop west side
- Replacement safety netting along south side of SW backstop at Delbrook Park (to protect the new Delbrook playground below the field)

2021 Capital Projects – Parks

Inter River Park – All terrain field The project includes:

- A multi-sport tournament sized lit artificial turf field to accommodate soccer, football and field hockey, with a baseball backstop and warm up area.
- New improved vehicle access and parking areas
- Improved trails and linkages and signage
- New landscaping and drainage
- Potential new washroom to serve both the upgraded lacrosse box and the bike park area

Playgrounds (Bridgman)

- Park Furniture upgrades to improve accessibility to park benches & picnic tables
- Trail Program MTN Highway interchange, Cates park (ramps replace stairs where possible),

Delbrook Park – Fieldhouse & Accessible Path

The new accessible pathway will be built in the spring of 2021.

• Path entry area features two accessible parking spots opposite the path entry.

- Both parking spots feature low asphalt ramps to overcome the 8 inch raised curb
- Proposed grades; pathway outside entry = 6.8
- Proposed grades at path entry: 5%
- Proposed grades along path: 3-4%
- Revised accessible parking as per comments from ACDI October meeting 2020
- 2 metre safety zone around single ramp between to new accessible spots
- Require new approved accessible logo for accessible parking spots (unable to use one sent)

Delbrook Lands

- Detailed Park design Fall 2020 to Spring 2021
- New design will feature:
 - Wide accessible pathways
 - Accessible play spaces and water park
 - Accessible parking
 - Focus on ramps and less on stairs for ease of movement
- Drawing above 2020 conceptual Design from extensive public process (2018/2019)
- Construction: possibly 2022/23

- Rapid Bus Lunch
 - Implemented the recommended bus stop accessibility measures by the ACDI relating to shelters and tactile warning surface indicators

 - Focus on making public and private spaces accessible
 - Temporary bus extensions have been improved

2.3. District of West Vancouver

TRRIP (TransLink - Transit Related Road Infrastructure Program) Purposes:

- Improve pedestrian transit experiences on the roadways to encourage a shift from single occupancy vehicles to transit use.
- Improve sidewalk/pedestrian infrastructures that expand accessibility at bus stops.
- Achieve more efficient operation of the District's transit facilities.

Two locations are proposed to improve in 2021:

- Ballantree at St. Andrews Intersection Improvements
- Primrose at Marine Drive Bus Stop Improvements

Ballantree at St. Andrews Intersection Improvements

- Install Monolithic Concrete Sidewalks with Letdown
- 16.5m of Handrail at the back of sidewalk
- Install Pedestrian Signage
- Zebra Crosswalk
- Line Painting (Stop Bar, Pedestrian Crosswalk Lines, etc.)

Primrose at Marine Drive Bus Stop Improvements

Install Concrete Sidewalk with Letdown

 Install Pedestrian Signage Zebra Crosswalk

13th & Marine Signal Replacement

- Scope of work: installation of new traffic signal poles, removal of existing ones, junction boxes, vehicle detection and wiring.
- Apply technical advantages of the new controller.
- It includes future traffic coordination, Accessible Pedestrian Signal (APS) for pedestrian safety, and new LED traffic lights.
- New Detection System with cameras.

Strategic Transportation Plan (STP)

- The process of stakeholder engagement will start in early 2021.
- ACDI committee will be engaged for inputs, stay tuned for updates

Horseshoe Bay Streetscape

- Approximately 100m of local road upgrades along Royal Ave, including curb relocation, pavement reconstruction, new lighting, and landscaping.
- ACID comments were incorporated:
 - Crosswalk treatment
 - Use of bollards in crosswalks
 - Pedestrian "Zone"
 - Street Furniture
 - Project is nearly completion

2020 Community Services

Participation in North Shore wide COVID-19 response with a West Vancouver focus on:

- people experiencing food security
- homeless and those at-risk of being homeless

New lobby furniture designed to meet a variety of needs and chosen in consultation with members from the community

2020 Parks

Juniper Loop trail improvements (Lighthouse Park) in coordination with a grant from the Rick Hansen Foundation:

- Extension of road pavement and the introduction of two paved accessible parking stalls at the Northern Juniper Loop Trail Head
- Regrading, widening and smoothing of trail surface for approximately 300m of the trail
- A new rest bench midway
- Trail head signage with some improvements to the trail kiosk

2021 Capital and Work Plan

An RFP for an operator for the supportive housing units at Gateway (Park Royal) will be on BC Bid in early 2021

- Ferry Building renovation Will come forward to the ACDI in 2021
- Recreation Financial Assistance to fully move online or over the phone, with inperson appointment by request once COVID restrictions are lifted.

The following item was raised from the District of North Vancouver:

• At a recent Council meeting, signage at Lynn Valley Centre was considered. As part of the discussion, it was questioned if the District has guidelines on accessibility issues for signage. The Sign Bylaw is generally silent on this but a sign designer noted that international standards do exist (e.g. for legibility) and that most sign designers incorporate these provisions into their signs. This item was relayed to the Committee for information and for possible consideration in future work plans (e.g. establishing accessibility standards that could be incorporated through the sign permit application process).

The following item was raised from the District of West Vancouver

 Council will be looking at updating their strategic goals and one of the objectives from last year was to expand the diversified housing and rentals and accessible units. As there are no accessibility guidelines the Committee may also wish to look at working on developing housing accessibility guidelines.
